ORDER:

The Hon'ble Chief Minister has made an Announcement in the Floor of the Assembly under Tamil Nadu Assembly Rule. 110 on 23.09.2015 for the Establishment of Biosafety Level-III (BSL3) Laboratory at Tamil Nadu Veterinary and Animal Sciences University campus, Madhavaram at a budget outlay of Rs.12.75 crore.

2. In the letter first read above, the Director of Research, Tamil Nadu Veterinary and Animal Sciences University has sent a proposal for establishment of Biosafety Level III (BSL3) Laboratory with Small Animal Experimentation Facility at Tamil Nadu Veterinary and Animal Sciences University campus, Madhavaram at a budget outlay of Rs.12.75 crore.

3. In the letter second read above the aforesaid proposal of the Director of Research, Tamil Nadu Veterinary and Animal Sciences University has been approved by the State Planning Commission subject to the condition that 20% of revenue earned

through this scheme should be remitted to the Innovation Fund of the State and also recommended to release Rs.8.00 crore for the first year (2015-2016) and Rs.4.75 crore for the second year (2016-2017).

4. In the reference fourth read above, the Registrar, Tamil Nadu Veterinary and Animal Sciences University has requested the Government to issue necessary orders for the establishment of the Biosafety Level III (BSL3) Laboratory.

5. The Government after careful examination accept the proposal of Tamil Nadu Veterinary and Animal Sciences University for the Establishment of Biosafety Level-III (BSL3) Laboratory at a budget outlay of Rs. 12.75 crore (Rupees Twelve crore and Seventy five lakh only) and to release a sum of Rs.8.00 crore (Rupees Eight crore only) for the first year (2015-2016) as recommended by the State Planning Commission, under Tamil Nadu Innovation Initiatives (TANII).

6. The expenditure sanctioned in para 5 above shall be met from State Innovation fund and debited to the following Head of Account:-

"2415-Agricultural Research and Education-03 Animal Husbandry-004-Research. II. State Plan – JA Establishment of Bio-Safety Level-III Laboratory – Scheme Under State Innovation Fund – 09 - Grants-in-Ald-03, Grants for Specific Schemes"
