ORDER:-

In the letter first read above, the Member Secretary, State Planning Commission, has conveyed his recommendation for purchase of 300 Electronic Jacquard with Pneumatic Drive System at a cost of Rs.1,20,00,000 per year for next 3 years as an Innovative Initiative on 60:40 basis to be shared between State Government and the weavers Co-operative Societies.

2. In the letter second read above, the Director of Handlooms-and Textiles has stated among others that they have proposed to purchase, Electronic Jacquard Operated with Pneumatic Drive System for Handlooms in order to promote the sale of silk products in domestic and international market designs have to be updated periodically according to the changing trends in the market. Electronic Jacquard is one of the new accessory developed for Handlooms. Electronic Jacquard is to create new designs which will come in the saree without any hassle. The operating system of Electronic Jacquard is designed in such a way even unskilled weaver can operate easily. The Director of Handlooms and Textiles has also furnished the advantages of Electronic Jacquard as follows:—

He tentative cost for purchase of one Electronic Jacquard with Pneumatic Drive system is stimated to Rs.2,00,000/-. The cost will be borne by State Government and Beneficiary/Society Contribution in the ratio of 60:40. It is proposed to purchase 300 Electronic Jacquard with Pneumatic Drive System for Handlooms over a period of 3 years, for which, financial assistance of Rs.6 Crore is required. The State Government Contribution is Rs.3.60 Crore and beneficiary Contribution/Society Contribution is Rs.2.40 Crore.

- 3. The Director of Handlooms and Textiles has therefore requested the Government to issue necessary orders to approve purchase of 100 Electronic Jacquard Operated with Pneumatic Drive System per year for 3 years at a total cost of Rs.6 crore under State Innovation Fund and requested to sanction a sum of Rs.1,20,00,000/- in first phase Under State Innovation fund towards State Government contribution for purchase of 100 Electronic Jacquard operated through Pneumatic Drive System for Handlooms for the year 2015-2016.
- 4. The Government after careful consideration, accept the proposal of Director of Handlooms and Textiles for purchase of 300 Electronic Jacquard Operated through pneumatic system for Handlooms at a total cost of Rs.6.00 crore (Rupees Six crore only) from "State Innovation Fund" as detailed below:-

- 5. As per the approval of project set out at para 4 above, sanction is accorded to a sum of Rs.1,20,00,000/-(Rupees One crore and twenty lakh only) in first phase under Tamil Nadu Innovation Initiatives Schemes [part-II schemes] for the purchase of 100 Electronic Jacquard operated through Pneumatic Drive System for Handlooms for the year 2015 –2016.
- 6. The amount sanctioned in para 5 above shall be met from the State innovation fund and debited to the following head of account:-


