#### ORDER:

The Tamil Nadu State Election Commission has proposed to introduce specially designed Electronic Voting Machines to accommodate 4 votes system (District Panchayat Ward Member, Panchayat Union Ward Member, Village Panchayat President and Village Panchayat Ward Member) in the Elections to Rural Local Bodies on pilot basis in the Melpuram Panchayat Union in Kanniyakumari District, which involves purchase of 94 Nos. of Control Units and 392 Nos. of Ballot Units at a total cost of Rs.40.29 Lakhs.

- 2. The State Planning Commission has appraised and recommended the above proposal under Tamil Nadu Innovation Initiatives Schemes for the year 2015-16 and the Standing Finance Committee has approved the proposal.
- 3. Sanction is, therefore, accorded for a sum of Rs.40.29 Lakhs (Rupees Forty Lakhs and twenty nine thousand only) towards the purchase of Specially Designed Electronic Voting Machines to accommodate 4 votes system under Tamil Nadu Innovation Initiatives Schemes for 2015-16 from Bharat Electronics Limited.
