ORDER:

The Director of Handlooms and Textiles has submitted a project proposal for Rs.11.25 lakh towards purchase of 75 Washing-cum-Rinsing Machines for the Silk Dyeing Units over a period of 3 years for approval under "State Innovation Fund".

2. The State Planning Commission has after discussion recommended the above project on 80:20 basis over a period of 3 years between the Government and Weavers Co-operative Societies as follows:-

- 3. The Government accepts the proposal of Director of Handlooms and Textiles as per the funding pattern set out in para 2 above.

Accordingly, sanction is also accorded for the release of a sum of Rs.3,00,000/- (Rupees three lakhs only) towards State Government contribution for the first phase under Tamil Nadu Innovation Initiatives Schemes (Part-II Schemes) for purchase of 25 Washing-cum-Rinsing Machines for the Silk Dyeing Units of Silk Handloom Weavers' Co-operative Societies for the year 2015-16.
- 5. The expenditure sanctioned in para 4 above shall be met from the State Innovation Fund and debited to "2851-00-Village and Small Industries 103. Handloom Industries Schemes in the Twelfth Five Year Plan-II. State Plan-LC. Purchase of Washing –cum- Rinsing Machine for Silk Dyeing Units Scheme under
