ORDER:

The Principal Chief Conservator of Forests has stated that due to various anthropogenic and ecological reasons, human wildlife conflict is on persistent increase. In Madurai Division, there have been more than 50 cases in last 4 month where wildlife (such as Monkeys, Snakes, Peacocks, etc.,) have been rescued from human habitations and released in forest areas. It is necessary to engage and utilize the services of Volunteers who are residing close to such vulnerable areas where human wild life conflict is more likely to happen. He has therefore proposed that two volunteers from each of such vulnerable villages will be selected, trained and utilized to rescue and release of wild animal and proposed to implement the scheme at a cost of Rs.30.00 lakh for following item of works during 2015-2016.

The Government after careful consideration accept the proposal of the Principal Chief Conservator of Forests and accord sanction for a sum of Rs.30.00 lakhs (Rupees Thirty lakhs only) towards Training and utilizing services of volunteers in Rescue and Release of Wildlife under State Innovation Fund for the year 2015-2016.

He is requested to ensure that the amount sanctioned above is utilized in full during 2015-16 and to send the Utilization Certificate as soon as the work is completed.
