ORDER :-

The Standing Finance Committee has approved the proposal of the Director, Fire and Rescue Services Department, Chennai, for procurement of 5 Education Vans to train the society at their door steps to handle fire and other emergencies at a cost of Rs.100.00 lakhs (Rupees Hundred lakhs only) under Tamil Nadu Innovation Initiatives Schemes for the year 2015-2016 and necessary provision has been made in the Supplementary Estimates for the year 2015-2016.

- 2. The Government accordingly sanction a sum of Rs.100.00 lakhs (Rupees One crore only) for procurement of 5 Education Vans to train the society at their door steps to handle fire and other emergencies.
- 3. The expenditure sanctioned in para 2 above shall be debited under the following head of account.

The above expenditure shall be met from the State Innovation Fund deducting under the following new head of account opened under Demand No.23 HOD:01

"2070-00-Other Administrative Services-902 Deduct – Amount met from State Innovation Fund – JA Deduct – Amount met from State Innovation Fund – 30 Inter Accounts transfer [DPC.2070-00-902-JA.3008]".

- 4. The Director of Fire and Rescue Services is the Estimating, Reconciling and Controlling authority for the above new head of account "2070 – 00 – 902 – JA".
- The Pay and Accounts Officer's / Treasury Officer's are directed to open the new head of account in their book of accounts.
- 6. The Director of Fire and Rescue Services Department is authorized to incur the expenditure sanctioned in paragraph 2 above. He is also directed to follow the guidelines for procurement of 5 Education Vans to train the society at their door steps to handle fire and other emergencies by following the purchase procedures and codal provisions as applicable under the rules and orders in force.
