## ORDER :

In the Government Order first read above, orders have been issued for the establishment of Tamil Nadu Innovation Initiatives (TANII) in the State Planning Commission to promote Innovation in Government and Government agencies and to set up a State Innovation fund with an initial corpus of Rs.150.00 crores by restructuring the existing part II schemes from the financial year 2015 - 2016.

2. In Government Order second read above the detailed guidelines for identification and implementation of Innovation Schemes are issued. In Government Order third read above, orders have been issued on accounting procedure for transactions under State Innovation Fund.

3. In letter fourth read above, the Member – Secretary, State Planning Commission has recommended the proposal on Legal Metrology Complaint Tracking System with the commitment of Rs.26.30 lakhs from State Innovation Fund.

4. In the meantime, the Hon'ble Minister for Labour has also made an announcement on the floor of the assembly that the Mobile Applications to redress the consumer's complaints with regard to Legal Metrology and Packaged commodities will be established for the first time in India.

5. In the letters fifth read above, the Commissioner of Labour has stated that the 'Functional Requirement Document' of the project from the TNeGA has been approved and the TNeGA has been requested to Proceed further. She has therefore requested to issue necessary Orders for drawl of Rs.26.30 lakhs (i.e) cost for development of software to the tune of Rs.10.80 lakhs and purchase of 310 smart phones to the inspection authorities to the tune of Rs.15.50 lakhs from the State Innovation Fund under relevant Head of Account.

6. The Government after careful consideration, accords sanction for a sum of Rs.26.30 lakhs (Rupees Twenty Six Lakhs Thirty thousand (Dnly) from the State Innovation Funds for the project of "Legal Metrology Complaint Tracking Systems (LMCTS).

7. The amount sanctioned in para 6 above shall be debited to the following Head of Account.
