### ORDER:

In the letter read above, Director of Municipal Administration has submitted a research project called Ground Water Sanitation Nexus Research Project in small towns of Namakkal District with detailed budget estimates in order to examine and alleviate the challenges to ground water quality posed by poor sanitation and with the aim of developing a sustainable faecal sludge management framework in the State of Tamil Nadu using Namakkal and Erumaipatti towns as case examples. He has also requested the Government to take up the proposal to State Planning Commission for the allocation of fund under Tamil Nadu Innovation Initiatives 2015-16.

2. The State Planning Commission has recommended the proposal for a research study with objective to develop a low cost sustainable on-site sanitation technology, at a total cost of Rs.60 lakh in Namakkal District (NGO's contribution would be Rs.30 lakh and the remaining Rs.30 lakh from the Innovative Fund) in collaboration with the Non Governmental Organization Arghyam Foundation. While stating that the projects executed by Non Governmental Organizations of repute can be considered, provided that in every such case, evaluation of the innovative suggested that, without having the impact evaluation, Government may decide whether this project can be funded under Tamil Nadu Innovation Initiatives

3. After careful examination of the proposal in the light of the recommendation of the State Planning Commission, the Government accord sanction for a sum of Rs.30.00 lakh (Rupees thirty lakh only) towards implementing the project of Study on linkages between Sanitation and ground water quality in Namakkal District under the Tamil Nadu Innovation Initiatives Schemes Fund.

4. The amount sanctioned in para-3 above shall be debited into the following head of account:-

"2215.Water Supply and Sanitation-02. Sewerage and Sanitation -800. Other expenditure – Schemes in Twelfth Five year plan-II. State Plan – JK. Study on linkage between sanitation and Ground Water quality in Namakkal District – Scheme under State Innovation Fund – 09. Grants in Aid-01. Grants for Current Expenditure". (DPC:2215-02-800-JK-09 11)

5. The above expenditure shall be met from the State Innovation Fund by deducting under the following new head of account opened under Demand No.34 HOD:02

"2215.Water Supply and Sanitation-02. Sewerage and Sanitation -902. Deduct – Amount met from Reserve Fund-JA. Amount met from the Reserve Fund-30. Inter-Account Transfers. (DPC:2215-02-902-JA-3001)

and contra debiting "J Reserve Fund (b) Reserve Funds not bearing Interest – 8229 00 Development and Welfare Funds – 200 Other Development and Welfare Funds – BE State Innovation Fund. (DPC:8229 00 200 BE 0006) (outgo)"

6. The Director of Municipal Administration is the Estimating, Reconciling and controlling authority for the above new sub head of account " 2215.02-902 JA"

7. The Pay and Accounts Officers / Treasury Officers are directed to open the above new head of account in their books.

8. Necessary Funds has been provided in the First supplementary estimates 2015-2016. The Director of Municipal Administration is hereby authorized to draw & disburse the amount sanctioned above.
