
ORDER:-

The Standing Finance Committee has approved the proposal of the Additional Director General of Police / Inspector General of Prisons for purchase and installation of Security Pole for Cellphone and Ferrous Metal detection System in 9 Central Prisons and 3 Special Prisons for Women under Tamil Nadu Innovation initiatives schemes for the year 2015-2016 at a total cost of Rs.159.48 lakhs and necessary provision has been made in the Supplementary Estimates for the year 2015-2016.

- 2. The Government accordingly sanction an amount of Rs.159.48 lakhs (Rupees One crore fifity nine lakhs and forty eight thousand only) towards purchase and installation of security pole for Cellphone and Ferrous Metal detection System in 9 Central Prisons and 3 Special Prison for women under Tamil Nadu Innovation Initiatives schemes for the year 2015-2016.
- 3. The above expenditure sanction in para 2 above shall be debited to the following head of account:-
