ORDER:-

During the Assembly session for the year 2015 – 16, among others, the Hon'ble Chief Minister of Tamil Nadu has announced under the Rule 110 of Tamil Nadu Legislative Assembly Rules on 25.9.2015 as follows:-

- " இயற்கை பேரிடர் காலங்களில் மீட்புப் பணிகள் மற்றும் பாதுகாப்பு பணிகள் சிறப்புற மேற்கொள்ள ஆளில்லா வான்வெளி வாகனம் மிகவும் பயனுள்ளதாக இருக்கும். இவ்வாகனம் பாதிக்கப்பட்ட பகுதியை ஆய்வு செய்து மதிப்பு மிகுந்த தகவல்களை தர வல்லது. இவ்வாகனத்தின் திறன்களை பயன்படுத்தி அனுபவம் வாய்ந்த நிவாரண பணியாளர்கள் நிவாரணப் பணிகளை விரைந்து மேற்கொள்ள இயலும். அதே போல் பாதுகாப்பு அச்சுறுத்தல்கள் மற்றும் அபாயங்கள் ஆகியவற்றை கண்காணிப்பதற்கும் இது பயனுள்ளதாக அமையும். எனவே, ஆளில்லா வான்வெளி வாகனம் மூலம் தமிழக அரசின் பல்வேறு துறைகளுக்கு சிறப்பான சேவையை அளிக்கும் வகையில் அண்ணா பல்கலைக்கழகம் மூலம் ஆளில்லா வான்வெளி வாகனம் திட்டமிடப்பட்டு வடிவமைக்கப்படும். இத்திட்டத்திற்கென அண்ணா பல்கலைக்கழகத்திற்கு 20 கோடி ரூபாய் வழங்கப்படும் என்பதை மகிழ்ச்சியுடன் தெரிவித்துக்கொள்கிறேன்".
- 2. In the letter third read above, the Registrar, Anna University has sent a detailed proposal for the scheme of "Design and Development of Unmanned Aerial Vehicles" (UAVs) to Anna University, Chennal at a cost of Rs.20.00 crore.
- 3. The Government after careful consideration, sanction a sum of Rs.9,72,64,000/- (Rupees nine crore seventy two lakh and sixty four thousand only) for the year 2015 16 to Anna University, Chennai for the scheme of "Design development and Implementation of Unmanned Aerial Vehicles for Disaster and Societal Application" under State Innovation Fund, subject to the following conditions:
 - a) Before sanctioning the project, all the mandatory approvals from the appropriate authority including the Directorate General of Civil Aviation, privacy issues, Government departments such as Commissionerate of Revenue Administration, Director General of Police, Commissioner of Geology and Mining, Disaster Management has to be obtained.

- Approvals from the statutory bodies, for all the ingredients of the projects for its commercial applications have to be obtained and an appropriate governance structure developed.
- 4. The expenditure sanctioned in para 3 above shall be debited under the following head of account:-

"2203 - 00 Technical Education - 102 Assistance to Universities for Technical Education - Schemes in the Twelfth Five Year Plan - II. State Plan - JI Design, Development and Implementation of Unmanned Air Vehicles for Disaster and Socital Application - Scheme under State Innovation Fund - 09 Grants in Aid - 03 Grants for Specific Schemes" (DPC 2203 00 102 JI 0939).

 The above expenditure shall be met from the State Innovation Fund by deducting under the following head of account:-

2203 - 00 Technical Education - 902 Deduct - Amount met from State Innovation Fund - Schemes in the Twelfth Five Year Plan - II. State Plan - JA Deduct - Amount met from State Innovation Fund - 30 Inter Accounts Transfers.
