## ORDER:-

The State Planning Commission after detailed discussion has decided to fund for the Bio-digest Toilet components only. Accordingly recommended as follows:

The construction of ecofriendly bio digester toilet in 18 model schools at a total cost of Rs.18 lakhs (Rs.1 lakh for a toilet) and recurring cost of Rs.3.78 lakhs for the period of three years, subject to the condition that initially the Bio-digest Toilet be constructed in a model school as a model and after assessing the pros and cons of the model toilet, the other toilet be constructed duly rectifying the lacunas. The total recommended cost for the proposal is Rs.21.78 lakhs.

2. The Project Director, Rashtriya Madhyamik Shiksha Abhiyan has stated that the 18 Model Schools proposed are already functioning in the educationally backward blocks. The basic infrastructure was constructed by Police housing Corporation at a cost of Rs.3.00 crore. These 18 first phase model schools are having five acres of land and 7 non-teaching staff including a Gardener who can look after the garden related activities. Bio digestor technology has been developed for resolving the problems of un-decomposed human waste. The innovation degrades and converts the human waste into usable water and gases in an eco-friendly manner. The generated gas can be utilized for energy / cooking and water for irrigation purposes. The process involves the bacteria which fed upon the faucal matter inside the tank, through anaerobic process which finally degrades the matter and releases methane gas that can be used for cooking, along with the treated water. It is 0% maintenance free, continuous biological process and complete elimination of pathogens. It is economical, ease of use, eliminates mosquitoes and cockroaches, exempt of usual bad smell and easy maintenance. At present the water resources available in secondary schools are very scarce. So the

alternative model has been suggested for up scaling. The Bio-digester tank can be manufactured and customized as per the requirement. The main constituents of bio-toilet are pre-fabricated above the ground shelter and bio digester tank. Bio digester tank is cylindrical structure with the provision of inlet for human waste and outlet for bio gas. Bio Digester Toilet involves a unique technology wherein the human waste is decomposed in a specially designed digester using a specific anaerobic bacteria that works in the digester tank to break up the feaces into water and methane. This mechanism with the indigenized and novel techniques. Rather than wasting the water resources the toilets will be converted in to biodigestor toilets and the recycled water will be used for the green field development in the unused areas of the model schools. This project provides an alternative to flush toilets where there is no suitable water supply. A composting toilet is a dry toilet that uses a predominantly aerobic processing system that treats excreta, typically with no water. It requires less maintenance and environment friendly. The Project Director, Rashtriya Madhyamik Shiksha Abhiyan has now requested Administrative orders for a sum of Rs.21.78 lakh for the above project.

3. The Government accept the proposal of Project Director, Rashtriya Madhyamik Shiksha Abhiyan and accord administrative sanction for a sum of Rs.21.78 lakh (Rupees twenty one lakh seventy eight thousand only) (Rs.18 lakh (1 lakh for each model school) and recurring cost of Rs.3.78 lakh)) for the construction of Eco-friendly bio digest toilet in 18 model schools for a period of three years subject to the condition that initially the Bio-Digest Toilet shall be constructed in a school as a model and after assessing the pros and cons of the model toilet, the other toilets shall be constructed duly rectifying the lacunas. Under the Tamil Nadu Innovation Initiatives (TANII) under State Innovation fund for the year 2015-16 as approved by the State Planning Commission.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-
