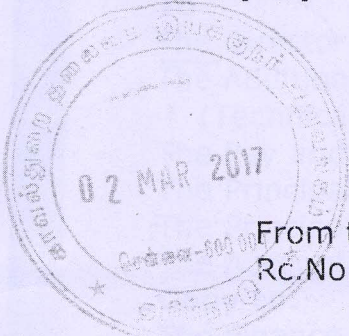
ORDER:-
