ORDER:-

The Standing Finance Committee has approved the proposal of the Additional Director General of Police / Inspector General of Prisons for Introduction of Electronic Key management system on pilot basis in Puzhal Prison Complex for replacing the existing conventional lock and key system with a modern key Management System at cost of Rs.86.03 lakhs and necessary provision has been made in the First Supplementary Estimates for the year 2017-2018.

2.The Additional Director General of Police / Inspector General of Prisons in his letter 3<sup>rd</sup> read above has furnished the detailed proposal for the introduction of Key Management System in Puzhal Prison at the cost of Rs.82.32 lakhs on pilot basis for consideration under Tamil Nadu Innovation Initiatives schemes for the year 2017-2018.

Accordingly the Government sanction an amount of Rs.82.32 lakhs (Rupees Eighty two lakhs and thirty two thousand only) towards Introduction of Electronic Key management system, on pilot basis in Puzhal Prison Complex for replacing the existing conventional lock and key system with a modern key Management System at cost of Rs.82.32 lakhs under Tamil Nadu Innovation Initiatives schemes for the year 2017-2018.


