**ORDER:**

In the letter 2<sup>nd</sup> read above, the Member Secretary, State Planning Commission (SPC) has informed that the proposal has been approved by the State Planning Commission for funding under TANII Scheme for the year 2017-18 (second round) at a reduced outlay of Rs.81.50 lakh for one year only.

3. The Government after careful examination accord sanction for a sum of Rs.81,50,000/- (Rupees eighty one lakh and fifty thousand only) for the project "Unified Content Management System and Portal Framework for Government of Tamil Nadu" under Tamil Nadu Innovation Initiatives Schemes for the year 2017-2018.
