ORDER:

The Principal Secretary/Industries Commissioner and Director of Industries and Commerce in his letter first and third read above has stated that the Salem Starch and Sago Manufacturer's Service Industrial Co-operative Society Ltd. popularly known as Sagoserve, is functioning under the administrative control of the Department of Industries and Commerce. It is the only Industrial Co-operative Society for marketing of Sago and Starch in India. Tapioca cultivation and Sago Starch are the back bone for rural economy of Salem region and provide employment to 5 lakh agricultural labourers including Tribal in tapioca field and 1 lakh unskilled industrial labourers in Sago and Starch Industries.

2. At present, the Sago and Starch products manufactured by the member units of Sagoserve are sold through Sago auction centre in a traditional method. In order to conduct the auction in a transparent manner and to adopt the perfect technically developed system, Sagoserve has proposed to set up e-auction facility at Sagoserve, Salem. Hence the Principal Secretary/Industries Commissioner and Director of Industries and Commerce has requested the

Government for Financial assistance of Rs.146.91 lakh under State Innovation Fund.

3. Accordingly, the above proposal was placed in the State Planning Commission during the TANII meeting held on 11.12.2018 and the same was approved by TANII with the following funding pattern:-

The balance amount of Rs.29.38 lakh will be met by Sagoserve, Salem.

4. Based on the approval letter 2nd read above received from the State Planning Commission and the request of the Principal Secretary/ Industries Commissioner and Director of Industries and Commerce in letter 3rd read above, the Government accord sanction for a sum of Rs. 1,17,53,000/- (Rupees One Crore Seventeen lakh and Fifty three thousand only) for setting up of E-auction System at Sagoserve, Salem under State Innovation Fund 2018-2019. (Round II). The Sagoserve, Salem shall meet the balance amount of Rs.29.38 lakh out of the proposed outlay of Rs.146.91 lakh for the above scheme.

5. The Expenditure sanctioned in para 4 above shall be debited to the following Head of Account:-
