**ORDER:**

The State Planning Commission has also requested to issue necessary sanction as per the guidelines and procedures prescribed in the reference first and second read above after obtaining the detailed proposals from the Head of Departments.

3. The Government hereby accord administrative and financial sanction for a sum of Rs.1,50,00,000/- (Rupees one crore fifty lakh only) towards following schemes:-
