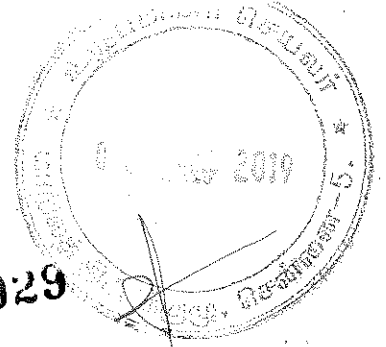

ORDER:

The Director, Evaluation and Applied Research Department has stated that the State Planning Commission has recommended the proposal of this department for the development of “Electronic File Management System (Office Automation for e-Evaluation) at a cost of Rs.45.00 lakhs under Tamil Nadu Innovation Initiatives for the year 2018-19 (Round-II).

2. In this regard, a meeting under the Chairmanship of Additional Chief Secretary to Government, Planning and Development Department has been held on 29-1-2019 in Secretariat with the Commissioner, Tamil Nadu e-Governance Agency, among others, for the development of Web portal for monitoring the implementation of Sustainable Development Goals, State Balanced Growth Fund, Special Area Development Programme etc., including the development of Electronic File Management System for the use of Evaluation & Applied Research Department. The Commissioner, Tamil Nadu e-Governance Agency has submitted a proposal at a cost of Rs.24.20 lakhs

for the development of Web portal application for the use of State Planning Commission for monitoring the implementation of Sustainable Development Goals, Tamil Nadu Innovation Initiatives (TANII), State Balanced Growth Fund, Special Area Development Programme etc., including the development of Electronic File Management System for the use of Evaluation & Applied Research Department.

3. It has been decided among other things that a sum of Rs.16.30 lakhs may be sanctioned by the Member, State Planning Commission from out of the amount approved for the State Planning Commission under Tamil Nadu Innovation Initiatives (TANII) for the year 2018-19 (Round-II) payable to the Commissioner, Tamil Nadu e-Governance Agency. The rest of the amount of Rs.7.90 lakhs may be sanctioned by the Director of Evaluation & Applied Research Department from out of amount of Rs.45.00 lakhs approved under Tamil Nadu Innovation Initiatives (TANII) for the Evaluation & Applied Research Department for the year 2018-19 (Round-II) for the development of Electronic File Management System payable to the Commissioner of Tamil Nadu e-Governance Agency.

4. Based on the decision taken in that meeting, the Director, Evaluation & Applied Research Department has sent a proposal to Government for sanction of Rs.7.90 lakhs out of the amount of Rs.45.00 lakhs approved under Tamil Nadu Innovation Initiatives (TANII) for the Evaluation & Applied Research Department for the year 2018-19 (Round-II) towards the development of the Electronic File Management System by way of creation of Web portal application to be executed by the Commissioner, Tamil Nadu e-Governance Agency.

5. The Government after careful consideration of the proposal of the Director of Evaluation and Applied Research, sanction a sum of Rs.7,90,000/- (Rupees Seven Lakhs and Ninety Thousand only) for the development of Web portal to be carried out by the Commissioner, Tamil Nadu e-Governance Agency, initially out of a sum of Rs.45.00 lakhs approved under Tamil Nadu Innovation Initiatives (TANII) for the year 2018-19 (Round-II). Orders releasing the balance amount of Rs.37.10 lakhs will be issued separately. Necessary provision has been made in the Final Supplementary Estimate 2018-2019.

6. The expenditure sanctioned in para 5 above shall be debited under the following Head of Account:

3475 – 00 – Other General Economic Services – 800 - Other Expenditure - State's Expenditure - JL Electronic File Management System (Office Automation for e-Evaluation under State Innovation Fund - 09 – Grants-in-Aid – 03 – Grants for Specific Schemes. (DPC 3475 00 800 JL 0903)

7. The above expenditure shall be met from the State Innovation Fund by a deduction under the Head of Account Demand No.36 Head of Department 03:
