ORDER:

In the letter read above, the Member Secretary, Sports Development Authority of Tamil Nadu has proposed to develop a Mobile Based Tournament Operating System for the use of sportspersons all over Tamil Nadu with a objective to promote equal opportunity and sustain high levels of participation in daily fitness, to support widespread organization of competitive Sports across the State for all categories of citizens in various sports especially State Games for Chief Minister's Trophy and to facilitate excellence in High Performance Sports in National and International arena.

- 2. The Member Secretary, Sports Development Authority of Tamil Nadu has therefore requested the Government for the Mobile Based Tournament Operating System for the use of sportspersons at an estimate cost of Rs.33.00 lakh under Tamil Nadu Innovation Initiative (TANII).
- 3. The State Planning Commission has recommended to develop a Mobile Based Tournament Operating System for the use of sportspersons for the year 2018-19 (Round-I) as detailed below.

- 4. The Government after careful consideration accord Administrative Sanction for a sum of Rs.33,00,000/-(Rupees Thirty three lakh only) for a period of 3 years as detailed in para 3 above and accord financial sanction for a sum of Rs.16,00,000/- (Rupees Sixteen Lakh Only) for the financial year (2018-19) for developing a Mobile Based Tournament Operating System for the use of sportspersons all over Tamil Nadu.
- 5. The Expenditure sanctioned in para 4 above shall be debited under the following head of account:-

"2204-00 Sports and Youth Services – 104 Sports and Games-State's Expenditure - KY Grants for Mobile based Tournament Operating System – Under State Innovation Fund – 09 Grants-in-Aid – 03 Grants for Specific Schemes" (DPC: 2204 00 104 KY 0931)

6. The above expenditure shall be met from the State Innovation Fund by deducting under the following head of account.

"2204 - 00 Sports and Youth Services - 902 Deduct - Amount met from State Innovation Fund - States Expenditure - JB Deduct - Amount met from State Innovation Fund - 30 Inter Account Transfers." (DPC: 2204 00 902 JB 3004)

The Member Secretary, Sports Development Authority of Tamil Nadu shall prepare the bill and present it to the Pay and Accounts Office, Secretariat, Chennai-9 through the Under Secretary to Government, Youth Welfare and Sports Development Department, Chennai during 2018-2019. The above sanctioned amount shall not be paid in cash but shall be credited into the following Head of account:-
