ORDER:-

The Principal Chief Conservator of Forests has sent the proposal in the references first and third read above for the scheme "Advanced barrier through erection Fencing along RF boundaries to mitigate human-wildlife conflict" and requested the Government to sanction an amount of Rs.261.85 lakh under TANII - State Innovation Fund for the year 2018-2019 (Round-I).

2. In the letter second read above the State Planning Commission has recommended this scheme with staff cost for first year only. Accordingly, assistance arrived under TANII is Rs.261.85 lakh as follows:-

- 3. The Hon'ble Minister (Forests) has made the following announcement on the floor of Assembly on 29.05.2018:
 - "… யானைகள் நடமாட்டத்தை தடுப்பதற்கு ஓரடுக்கு தடுப்பு போதுமானதாக இல்லை. மேலும், பாதிப்புக்கு உள்ளாகும் பகுதிகளை கண்டறிந்து பல்வகை அடுக்கு தடுப்பு அமைப்புகள் (யானைபுகா அகழிகள் மற்றும் சூரிய மின்வேலி / சிறப்பு கட்டமைப்புகள்) ஏற்படுத்தப்பட்டுள்ளன. எனவே, வலுவான மற்றும் எளிதில் பராமரிப்பு செய்யும் வகையில் பாதுகாக்கப்பட்ட வனப்பகுதியில் தூண்களுடன் கூடிய கம்பிக்கயிறு வேலி அமைக்கும் புதுமையான திட்டம் மாண்புமிகு முதலமைச்சர் அவர்களின் ஆணையின்படி 2018–2019 முதல் 2020–2021 வரையில் ரூ.2.62 கோடி செலவில் செயல்படுத்தப்படும்."

The Government after careful consideration, accept the proposal of the Principal Chief Conservator of Forests and Chief Wildlife Warden and accord administrative sanction for a sum of Rs.253.41 lakh (Rupees Two crore fifty three lakh and forty one thousand only) and release a sum of Rs.221.25 lakh (Rupees Two crore twenty one lakh and twenty five thousand only) for the scheme of "Advanced barrier through erection of Wire Rope Fencing along RF boundaries to mitigate human-wildlife conflict" under TANII State Innovation Fund during the year 2018-2019 (Round-I), as annexed to this order.
- 5. (i) The expenditure sanctioned in para-4 above shall be debited to the following head of account:-
