## ORDER:

The Director of Public Health and Preventive Medicine in his letter read above has sent a proposal recommended by State Planning Commission under Tamil Nadu Innovation Initiative(TANII) (Second Round) 2018-2019 as follows:-

#### a) Introduction:-

Communication is a process that leads to desired changes in human behavior and informed individual and community participation to achieve predetermined goals. In recent years, communication has developed into an interdisciplinary science drawing richly from social sciences. Communication and education are interwoven.

Health education is a process aimed at encouraging people to want to be healthy, to know how to stay healthy, to do what they can individually and collectively to maintain health and to seek help when needed. The primary function of health education is to provide scientific knowledge or information to people about health problems. People rarely seek such information although they have a right to know the facts about health and diseases. Health education is the foundation of a preventive health care system.

#### b) Rationale:-

Health education is one of the most cost-effective interventions. A large number of diseases could be prevented with little or no medical intervention if people were adequately informed and encouraged to take necessary precautions in time.

Currently, the state is facing major challenges from the emerging and re-emerging infectious diseases due to globalisation. Also, the mortality and morbidity caused by Non-Communicable diseases is a major threat to the people. All these diseases can be prevented and controlled by proper health education. For example, mosquito-borne diseases could be easily controlled by proper water storage and solid waste management techniques. Majority of the Non-Communicable diseases could be addressed by diet and physical activity. Hence, the Information, Education and Communication component plays a major role in the prevention and control of diseases. Through this project various IEC materials like

Handbills, posters, pamphlets, Banners and audio clips will be prepared at this directorate and disseminated to all parts of the state.

# c) Challenges and Gaps in the Existing System:-

The Directorate has no Digital Communication Centre for Health education system currently. It also causes delay in the communication of the health education materials especially during the emergency situations like Floods, Cyclone and other diseases like Dengue fever, Zika viral disease, Nipah Virus fever, Ebola, etc., The absence of such centre also leads to compromise of quality of Health education materials prepared.

## d) Objective of the proposed project:-

 To establish a "Digital Communication centre for Health Education" at Directorate of Public Health and Preventive Medicine office.

## f) Expected benefits:-

- 1. The centre will help to prepare the IEC materials at stipulated time period with good quality and communicate at the required time
- 2. The Health education process will encourage people to adopt and sustain health promoting lifestyle and practices.

## g) Sustainability:-

This proposal involves a one-time expenditure on civil infrastructure and computers with software. The recurrent costs related to manpower and hardware can be met out from National Health Mission funds.
