ORDER:

The following project of Tamil Nadu Agricultural University has been approved by the State Planning Commission under Tamil Nadu Innovation Initiatives (TANII) (Second Round) at a total cost of Rs.100.00 lakh for a period of two years:-

"Accelerated Vermi-compost Production through automation".

2) The main aim of the project is to establish accelerated vermicompost production unit, to integrate the possible synergetic technologies for the accelerated bio-conversion of farm wastes into vermicompost through machinery and mechanized tools and to transfer the technology on accelerated bioconversion of farm wastes into vermicompost to the farmers, venture capitalists and extension personnel.

- 3) Accordingly, the Registrar, Tamil Nadu Agricultural University has requested the Government to issue necessary orders for administrative approval for the implementation of the project viz., Accelerated Vermi-compost Production through automation at a total cost of Rs.100.00 lakh for a period of two years (2019-2020 and 2020-2021) and also requested to release an amount of Rs.60.00 lakh towards implementation of the scheme for the first year 2019-2020.
- 4) The Government, after careful examination, accept the request of the Registrar, Tamil Nadu Agricultural University and accord administrative approval for implementation of the project viz., Accelerated Vermi-compost Production through automation at a cost of Rs.100.00 lakh for a period of two years (2019-2020 and 2020-2021) and also financial sanction is accorded for a sum of Rs.60.00 lakh (Rupees Sixty lakh only) as first year release for implementation of the scheme under TANII Project for the year 2019-2020.
- 5) The amount sanctioned in para 4 above shall be debited under the following Head of Account:-

"2415- Agricultural Research and Education - 01 - Crop Husbandry - 120 - Assistance to other Institutions - AH - Accelerated Vermi -compost Production through automation under State Innovation Fund - 309 Grants-in-Aid - 03 Grants for Specific Scheme".

- 7) Necessary additional funds of Rs.20.00 lakh will be provided in Revised Estimate/Final Modified Appropriation 2019-2020. Pending provision of such funds, the Joint Director of Agriculture, Coimbatore is authorized to draw the amount sanctioned in para 4 above and disburse the same to the Tamil Nadu Agricultural University. However, the expenditure shall be brought to the notice of the Legislature by **Specific Inclusion** in the Supplementary Estimate 2019-2020. The Registrar, Tamil Nadu Agricultural University is directed to include this expenditure while sending the Budget Proposal for Revised Estimate/Final Modified Appropriation 2019-2020 and also to send necessary draft explanatory notes for including the above said expenditure in the Supplementary Estimates 2019-2020 to Government in Finance (BG-I/Agri) Department at the appropriate time without fail.
- 8) The Registrar, Tamil Nadu Agricultural University is directed to follow the existing Finance procedures / Government orders while incurring the expenditure under each item from the amount sanctioned in para 4 above. He is also directed to inform the progress of the work and expenditure made every month to Government.
- 9) This order issues with the concurrence of Finance Department vide its U.O.No.18079/Agri/2019, dated 06.06.2019 and Additional Sanction Ledger No.398 (Three hundred and ninety eight).
