ORDER

The State Planning Commission has recommended the proposal of the Director-General of Police, Tamil Nadu, for the purchase of 3D Scanning System for Incident Investigation and Webcasting for all Police Ranges, Commissionerate and Headquarters at a cost of Rs.3,35,43,000/-(Rupees three crore thirty five lakh and forty three thousand only) under the Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2018-2019 (second round).

2. The Director-General of Police has informed that Government have provided funds for a sum of Rs.3,35,43,000/- (Rupees Three crore thirty five lakh and forty three thousand only) for the Scheme "3D Scanning System for Incident Investigation" and "Webcasting for all Police Ranges, Commissionerate and Headquarters" under the head of account in the First Supplementary Estimates, 2018-2019 and Revised Estimates, 2018-2019.

- 3. The Director General of Police, Tamil Nadu, has, therefore, requested to accord necessary administrative and financial sanction for a sum of Rs.3,35,43,000/- (Rupees Three crore thirty five lakh and forty three thousand only) to purchase the above mentioned equipments under the Tamil Nadu Innovation Initiatives (TANII) Scheme.
- 4. After careful examination of the proposal, the Government accord administrative sanction for a sum of Rs.3,19,43,000/- (Rupees Three crore nineteen lakh and forty three thousand only), i.e., Rs.89,00,000/- (Rupees eighty nine lakh only) as Non-Recurring expenditure for the purchase of 3D Scanning for Incident Investigation and Rs.2,30,43,000/- (Rupees two crore thirty lakh and forty three thousand only) for the purchase of Webcasting for all Police Ranges, Commissionerates and Headquarters, [(i.e., Rs.8,00,000/- (Rupees eight lakh only) as recurring and Rs.2,22,43,000/- (Rupees two crore twenty two lakh and forty three thousand only) as Non-Recurring expenditure (Recurring cost for first year only)] under the Tamil Nadu Innovation Initiatives (TANII) Schemes for the year 2018-2019 (second round), subject to the following condition:-
- i. The expenditure has to be incurred only for the purpose for which it is sanctioned by the State Planning Commission.
- ii. Unspent/Savings amount, if any, has to be surrendered.
- 5. The expenditure sanctioned in paragraph 4 above shall be met under the following head of account:

- ii. 2055.00.Police-Q01.Direction and Administration -State's Expenditure-JD.3D Scanning System for Incident Investigation under State Innovation Fund -319.Machinery and Equipments - 01.Purchase [IFHRMS DPC 2055-00-001-JD-31901] [Old DPC 2055-00-001-JD-1914]
- 6. The expenditure so incurred shall be adjusted by deducting under the following head of account. The actual expenditure incurred may be intimated to Finance (Home-I/BG-II) Department at an appropriate time:-

- 7. The Director-General of Police is directed to purchase the "3D Scanning System for Incident Investigation" and "Webcasting for all Police Ranges, Commissionerate and Headquarters" for a more effective policing and investigation.
- 8. Necessary funds will be provided in Revised Estimate/Final Modified Appropriation, 2019-2020 to meet the expenditure sanctioned in paragraph 4 above. Pending provision of such funds, the Director-General of Police is authorized to incur the expenditure. The Director General of Police is directed to include the expenditure sanctioned above, while sending the budget proposals for RE/FMA 2019-2020 to Government in Finance (Home-I) Department at the appropriate time without fail.
