ORDER:

The Principal Secretary/Industries Commissioner and Director of Industries and Commerce in his letter first read above has stated that the Irula Snake Catchers Industrial Co-operative Society Ltd is unique society functioning under the administrative control of the Department of Industries and Commerce. To upgrade the laboratory of the venom extraction unit in the above society to adhere to the guidelines issued by the World Health Organisation (WHO), the following instruments are essentially required.

As the society does not have sufficient funds of its own to purchase the above instruments at a total cost of Rs.30 lakh, the Principal Secretary/ Industries Commissioner and Director of Industries and Commerce has requested the Government for financial assistance under State Innovation Fund Scheme.
