### **ORDER:**

In the letter first read above the Member Secretary, State Planning Commission has conveyed his recommendation for 'Design and Development of Advance Dryer for Silk Skeins after Degumming / Dyeing Process' at a cost of Rs.9.00 lakh.

The Director of Handlooms and Textiles in the letter third read above has requested among other things to sanction a sum of Rs.9,00,000/- as 100% State Government share towards 'Design and Development of Advance Dryer for Silk Skeins after Degumming / Dyeing Process' under the Tamil Nadu Innovation Initiatives (TANII), State Innovation Fund (New Schemes) for the year 2019-2020.

3. The Government, after careful consideration of the proposal of the Director of Handlooms and Textiles accord sanction for a sum of Rs.9,00,000/- (Rupees Nine lakh only) for 'Design and Development of Advance Dryer for Silk Skeins after Degumming / Dyeing Process' under the Tamil Nadu Innovation Initiatives (TANII), State Innovation Fund (New Schemes) for the year 2019-2020.
