ORDER:

In the letter first read above the Member Secretary, State Planning Commission has conveyed his recommendation for 'Facilitating Co-optex Showrooms with RFID (Radio Frequency Identification Device)' at a cost of Rs.8.58 lakh.

The Director of Handlooms and Textiles in the letter third read above has requested among other things to sanction a sum of Rs.8,58,000/- as 100% State Government share towards 'Facilitating Co-optex Showrooms with RFID (Radio Frequency Identification Device)' under the Tamil Nadu Innovation Initiatives (TANII), State Innovation Fund (New Schemes) for the year 2019-2020.

3. The Government, after careful consideration of the proposal of the Director of Handlooms and Textiles accord sanction for a sum of Rs.8,58,000/- (Rupees Eight lakh fifty eight thousands only) for 'Facilitating Co-optex Showrooms with RFID (Radio Frequency Identification Device)' under the Tamil Nadu Innovation Initiatives (TANII), State Innovation Fund (New Schemes) for the year 2019-2020.

4. The amount sanctioned in para 3 above shall be met from the State Innovation fund and debited to the following head of account:-
