ORDER:

In the letter first read above, the Member Secretary, State Planning Commission has stated that during the meeting held on 13.11.2019 and 20.11.2019 with the related Secretaries to Government and Heads of Departments, 13 proposals received from the Health and Family Welfare Department has been appraised and recommended by the State Planning Commission. The Member Secretary, State Planning Commission has therefore requested the Government to issue necessary sanction duly obtaining detailed proposal from the Heads of Department in consultation with Finance department.

2. In the letter second read above, the Director of Medical Education has sent a proposal on the following project which is recommended for inclusion in Tamil Nadu Innovation Initiatives (TANII) 2019-2020 (Round II) by the State Planning Commission to the Government and requested necessary administrative and financial sanction in this regard:-

3. The brief description of the project on Mesenchymal Stem Cell (MSC) Secretome Analysis for non healing Wounds is as follows:-

i. Brief Description:

Mesenchymal Stem Cells (MSCs) Secretome (Conditioned medium) have a role in the inflammatory, proliferative and remodelling phases of wound healing. It also supports healthy, physiological functioning towards successful healing. As such therapeutic application of MSC secretome has been shown to enhance the wound healing in clinical settings. But before use in patients, the secretome needs to be completely characterized. Hence in this project the Government, aim to do proteomic profile and check the functional potency of Stem Cell Derived conditioned medium.

ii. Socio Economic Benefit:

Poor and needy People suffering from non-healing ulcers seeking treatment at Government Stanley Hospital, Chennai.

4. After careful examination, the Government have decided to accept the request of the Director of Medical Education. Accordingly the Government do and hereby accord administrative and financial sanction for a sum of Rs.18,82,51,600 (Rupees Eighteen Crore Eightytwo lakhs fifty one thousand and six hundred only) for the project on "Mesenchymal Stem Cell Secretome for treatment of non-healing ulcers" under Tamil Nadu Innovation Initiatives (TANII) 2019-2020 (Round II) as recommended by the State Planning Commission, as detailed in Annexure to this order.
