ORDER:

In the letter first read above, the Member Secretary, State Planning Commission has stated that during the meeting held on 13.11.2019 and 20.11.2019 with the related Secretaries to Government and Heads of Departments, 13 proposals received from the Health and Family Welfare Department has been appraised and recommended by the State Planning Commission. The Member Secretary, State Planning Commission has therefore requested the Government to issue necessary sanction duly obtaining detailed proposal from the Heads of Department in consultation with Finance department.

In the letter second read above, the Director of Medical Education has sent a proposal on the following project which is recommended for inclusion in Tamil Nadu Innovation Initiatives (TANII) 2019-2020 (Round II) by the State Planning Commission to the Government and requested necessary administrative and sanction in this regard:-

3. The brief description of the project on Probiotic study of Fermented Rice (PazhayaSorru) for treatment of Ulcerative Colitis is as follows:-

i. Brief Description:

Ulcerative colitis is a chronic inflammatory bowel disease with its incidence increasing and affecting patients during the most active period of their life (20-40 years of age). Conventional drugs such as steroids offer benefits but have limitations and side effects. Hence alternate naturally available treatment options could offer better and safe therapeutic effect. The present study proposes to use the fermented rice as a treatment option for managing Ulcerative colitis.

ii. Socio Economic Benefit:

Poor and needy People with Ulcerative Colitis seeking treatment at Gastroenterology department, Government Stanley Hospital, Chennai.

4. After careful examination, the Government have decided to accept the request of the Director of Medical Education. Accordingly the Government do and hereby accorded an administrative and financial sanction for a sum of Rs.272.74 lakhs (Rupees Two hundred and seventy two lakhs and seventy four thousand only) for the project on "Probiotic study of Fermented Rice (PazhayaSorru) for treatment of Ulcerative Colitis" under Tamil Nadu Innovation Initiatives (TANII) 2019-2020 (Round II) as recommended by the State Planning Commission, as detailed in Annexure to this order.
