### ORDER :

In the letter first read above, the State Planning Commission has, among others recommended for Establishment of Interventional Neurology Center at Rajiv Gandhi Government General Hospital, Institute of Neurology, Chennai.

2. Based on the above recommendation, the Mission Director, National Health Mission – Tamil Nadu has forwarded the proposals and requested the Government for Establishment of Interventional Neurology Center at Rajiv Gandhi Government General Hospital, Institute of Neurology, Chennai and sanction a sum of Rs.759.00 lakhs for the year 2019-2020 towards procurement and supply of Flat Panel Neuro BI-Plane Digital Subtraction Angiogram System and Mechanical Thrombectomy Kit at Rs.2.0 lakh per patient for 50 patients through Tamil Nadu Medical Services Corporation under Tamil Nadu Innovation Initiatives (TANII) funds.

- 3. The Government have examined the proposal in detail and
- Permit the Mission Director, National Health Mission Tamil Nadu to establish the Center for Interventional Neurology at Rajiv Gandhi Government General Hospital, Institute of Neurology, Chennai through TANII funds from the State Planning Commission at a cost of Rs.759.00 lakhs (Rupees seven crore and fifty nine lakh only) as detailed below:-
  - a) Sanction an amount of Rs.654.00 lakhs (Rupees six hundred and fifty four lakh only) towards procurement and supply of Flat Panel Neuro BI-Plane Digital Subtraction Angiogram System in Raiiv Gandhi

Government General Hospital (Cath lab) through Tamil Nadu Medical Service Corporation Limited with the specification approved by the committee constituted as per G.O. (Ms.) No.294, Health and Family Welfare Department, dated 26.09.2014.

- b) Sanction an amount of Rs.100.00 lakhs (Rupees one hundred lakh only) towards procurement and supply of Mechanical Thrombectomy Kit at Rs.2.0 lakh per patient for 50 patients through Tamil Nadu Medical Services Corporation Limited with the specification approved by the committee constituted as per G.O. (Ms.) No.294, Health and Family Welfare Department, dated 26.09.2014.
- c) Sanction an amount of Rs.5.00 lakhs (Rupees five lakh only) towards hiring of Expert Services (at Rs.10,000 per case) through Director / Head of Department Institute of Neurology, Rajiv Gandhi Government General Hospital, Chennai.

4. The amount sanctioned in para 3 above shall be met from the State innovation fund and debited to the following head of account:

Account of Tamil Nadu Medical Services Corporation Limited, Chennai.
