
1. State Planning Commission of Minutes of the SPC - TANII meeting vide Letter No.1600 / PC / SPC / 2019, Dated 28.11.2019.

2. From the Mission Director, National Health Mission-Tamil Nadu, Chennai, Letter Ref. No.341 / NHM / P9 / 2020, Dated 22.01.2020.

ORDER:

In the reference first read above, the State Planning Commission has, among others recommended for Modernization of labour room at Institute of Obstetrics and Gynaecology, Chennai and Government Rajaji Medical College Hospital, Madurai.

- 2. Based on the above recommendation, the Mission Director, National Health Mission-Tamil Nadu has forwarded the proposals and request the Government to accord administrative and financial sanction for a sum of Rs.1,79,93,000/- for Modernization of labour room at Institute of Obstetrics and Gynaecology, Chennai and Government Rajaji Medical College Hospital, Madurai through Tamil Nadu Medical Services Sorporation Limited under Tamil Nadu Innovation Initiatives (TANII) funds.
 - 3. The Government have examined the proposal in detail and to
 - Permit the Mission Director, National Health Mission -Tamil Nadu to Modernization of labour room at Institute of Obstetrics and Gynaecology, Chennai through Tamil Nadu Innovation Initiatives funds from the State Planning Commission.
 - Permit the Mission Director, National Health Mission Tamil Nadu to utilise the balance fund for Modernization of labour room at Government Rajaji Medical College Hospital, Madurai by provision of same set of equipment and civil work without exceeding the overall approval.
 - iii) Sanction an amount of Rs.100.22 lakhs (Rupees One crore and twenty two thousand only) towards procurement and supply of Medical Equipment for Labour room through Tamil Nadu Medical Services



- Corporation Limited. The details of brake-up of cost for Institutions is annexed to this order.
- iv) Sanction an amount of Rs.79.71 lakhs (Rupees Seventy Nine lakhs Seventy one thousand only) towards Furniture and accessories, Partitions, Workstation, Storage, Gas pipeline work, Tiles, Flooring and False ceiling etc at a cost of Rs.39.855 lakhs per institution to the 2 Hospitals of Institute of Obstetrics and Gyneacology, Chennai and Government Rajaji Medical College Hospital, Madurai.
- v) Permit the Mission director to carry out the above works through Director, Institute of Obstetrics and Gyneacology, Chennai and Dean / Head of Director, Government Rajaji Medical College Hospital, Madurai.
- 4. The amount sanction in para 3 above shall be provided as follows:-
