**ORDER:-**

In the reference first read above, the State Planning Commission has, among others, recommended for provision of 1 Inhaled Nitric oxide system and 1 High frequency ventilator each to the Special Newborn Care Units (SNCUs) at Madurai, Vellore and Thanjavur at a cost of Rs.93.00 lakh under Tamil Nadu Innovation Initiative (TANII) (Round – II) for the year 2019-2020.

2. Based on the above recommendation, in the reference second read above, the Mission Director, National Health Mission has forwarded a proposal and requested the Government to accord administrative and financial sanction for providing 1 Inhaled Nitric oxide system and 1 High frequency ventilator each to the Special Newborn Care Units (SNCUs) at Madurai, Vellore and Thanjavur at a cost of Rs.93.00 lakh under Tamil Nadu Innovation Initiative (TANII) (Round – II) for the year 2019-2020.

3. The Government, after careful examination of the proposal of the Mission Director, National Health Mission hereby accord administrative and financial Sanction

- (i) for Provision of 1 Inhaled Nitric oxide system and 1 High frequency ventilator each to the Special Newborn Care Units (SNCUs) at Madurai, Vellore and Thanjavur through TANII Scheme under State Innovation Fund at a cost of Rs.93.00 (Rupees Ninety three lakh only) at Rs.31.00 lakh per centre.



- (ii) The Mission Director, National Health Mission, Tamil Nadu is permitted to procure the above Equipment through Tamil Nadu Medical Services Corporation.

4. The amount sanctioned in para 3 above shall be met from the State innovation fund and debited to the following head of account :-

"2210-Medical and Public Health – 01 – Urban Health Services – Allopathy – 110 Hospital and Dispensaries – State's Expenditure – MA – Provision of advance facilities to the Special Newborn Care Units (SNCUs) under State Innovation Fund – 319 Machinery and Equipment – 01 Purchase – Rs.93.00 Lakhs".

5. The above expenditure shall be adjusted by deducting under the following head of account.

"2210-Medical and Public Health – 01 – Urban Health Services – Allopathy – 902. Deduct Amount met from State Innovation Fund – State's Expenditure – JB. Deduct – Amount met from State Innovation Fund – 330. Inter-Account Transfers"

6. By contra debiting from

"J. Reserve Fund – (b) Reserve Funds not bearing Interest – 8229-00. Development and Welfare Funds – 200. Other Development and Welfare Funds – BE. – State Innovation Fund"

7. The Mission Director, National Health Mission – Tamil Nadu is also directed to procure and install the equipment through Tamil Nadu Medical Services Corporation Limited, Chennai. Further, directed that the amount sanctioned in para 3 shall not be paid in cash but credited to the following Personal Deposit Account of Tamil Nadu Medical Services Corporation Limited, Chennai :-

"K. Deposit and Advances (b) Deposits not bearing Interest – 8443.00 – Civil Deposit – 800 – Other Deposits – CE Deposits of Tamil Nadu Medical Services Corporation Limited"

8. The Mission Director, National Health Mission – Tamil Nadu is authorized to draw and disburse the amount sanctioned in para 3 above.

9. Necessary funds have been provided in Second Supplementary Estimates 2019-2020/RE 2019-2020.

10. The Mission Director, National Health Mission – Tamil Nadu / The Project Director, Reproductive Child Health Project shall be the Estimating, Reconciling and Controlling Authority for the New Head of Account mentioned in para 4 above.
