ORDER:

The Hon'ble Minister for Dairy Development has made the following announcement on the floor of the Legislative Assembly on 05.07.2019.

"Cloud based Bulk Milk Collection Centre Monitoring system will be installed in 350 Bulk Milk Collection Centres in District Cooperative Milk Producers Unions at a cost of Rs.175 lakhs".

2. In the letter second read above, the Managing Director, Tamil Nadu Co-operative Milk Producers' Federation Limited based on the above announcement has sent a proposal to Government for forwarding it to Planning Commission to avail funds under TANII (Tamil Nadu Innovation Initiatives). The proposal was submitted for installation of cloud based Bulk Milk Collection Centre monitoring system for three years and the equipments are to be fixed on lease basis with install, maintain and operate basis to the value of Rs.5.04 crores.

- 3. In the letter third read above the State Planning Commission has recommended the proposal of Commissioner for Milk Production and Dairy Development with restricted outlay of Rs.63.00 lakh for the 50 Bulk Milk Collection Centres (12% out of total Bulk Milk Collection Centre).
- 4. In the letter fifth read above the Commissioner for Milk Production and Dairy Development has furnished the revised Detailed Project Report on the above proposal at cost of Rs.63.00 lakh for funding support under Tamil Nadu Innovation and Initiatives (TANII) for the year 2019-2020 and requested the Government to issue necessary orders to sanction a sum of Rs.63.00 lakh for implementation of the above scheme.

The Government after careful examination of the proposal of the Commissioner for Milk Production and Dairy Development and accord administrative sanction for a sum of Rs.63.00 lakh (Sixty three lakh only) and (Rs.21.00 lakhs for 2019-20, Rs.21.00 lakhs for 2020-2021 and Rs.21.00 lakhs for 2021-2022) and release a sum of Rs.21.00 lakhs (Rupees twenty one lakhs only) for implementation of the scheme "Cloud based Bulk Milk Collection Centre Monitoring system in 50 Bulk Milk Collection Centres in District Cooperative Milk Producers Unions under Tamil Nadu Innovation and Initiatives (TANII) for the year 2019-2020.
