ORDER:-

The Hon'ble Minister for Social Welfare and Nutritious Noon Meal Programme has made the following announcement on the floor of Tamil Nadu Legislative Assembly while moving demand for grants of Social Welfare and Nutritious Programme for the year 2020-2021:-

பெண்களுக்கு பொதுவாக காப்பக்காலத்தில் ஏற்படும் இரத்தசோகையினை களைந்து அவர்களுடைய ஊட்டச்சத்து நிலையை மேம்படுத்திடும் பொருட்டு, முன்னோடித் திட்டமாக சேலம், வேலூர், விழுப்புரம் ஆகிய மூன்று மாவட்டங்களில் அங்கன்வாடி மையங்களில் பதிவு செய்துள்ள காப்பிணிப் பெண்களில் இரத்த சோகை, குறைபாடுடைய காப்பிணிப் பெண்களுக்கு, ஒரு வருட காலத்திற்கு வீட்டுக்கு எடுத்து சென்று பயன்படுத்தும் வகையில் இரு முறை செறிவூட்டப்பட்ட உப்பு ரூபாய் 9.40 இலட்சம் செலவில் வழங்கப்படும்.

2. In the letter second read above, the State Planning Commission has recommended for the provision of Double Fortified Salt (DFS) to the anaemic ante natal women registered in Anganwadi centres in three districts viz., Salem, Vellore and Villpuram at the cost of ₹9.40 lakh.

- 3. Based on the approval of the State Planning Commission, the Director cum Mission Director, Integrated Child Development Services has sent proposal in the letter third read above stating that since iron deficiency (Anaemia) is most common and predominantly due to poor access of right food intake, it has been intended to increase the iron intake by providing Double Fortified Salt, which provides the vital micronutrients such as iron and iodine to pregnant women (Ante Natal women) in the first trimester. This will be further continued for a period of one year which will cover almost their entire pregnancy period and even after child birth to avoiding any growth falter to the foetus and support them to be free from anaemia. The Districts with higher percentage of anaemic Ante Natal women have been selected for the intervention. Around 10,120 Ante Natal women in the first trimester in the districts of Salem, Veilore and Villupuram have been selected for the provision of Double Fortified Salt for one year. The Double Fortified Salt will be procured from the Tamil Nadu Salt Corporation Limited, Chennai. The Anganwadi Worker will provide Double Fortified Salt to the Ante Natal Mothers registered in Anganwadi Centres. The Anganwadi Worker will also educate the Ante Natal Mothers about the importance of intake of Double Fortified Salt and follow up during their house visits.
- 4. The Director cum Mission Director, Integrated Child Development Services has requested to sanction a sum of ₹9,40,000 (Rupees Nine lakh forty thousand only) towards procurement and supply of Double Fortified Salt (DFS) of one kilogram pocket per month per beneficiary at the rate of 7.74 per kg to 10,120 (10,120x12=1,21,440 kilogram) Ante Natal Mothers register in the Anganwadi Centres in three districts viz., Salem, Vellore and Villupuram through the Tamil Nadu Civil Supply Corporation Limited, Chennal from April 2020 to March 2021.
- 5. After careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services, the Government issue following orders:
 - i. Sanction is accorded for a sum of ₹9,40,000 (Rupees Nine lakh forty thousand only) towards procurement of Double Fortified Salt (DFS) of one kilogram pocket per month per beneficiary at the rate of 7.74 per kg through Tamil Nadu Civil Supplies Corporation Limited, Chennai for supply to 10,120 (10,120x12=1,21,440 kilogram) Ante Natal Mothers registered in the Anganwadi Centres in three districts viz., Salem, Vellore and Villupuram from April 2020 to March 2021.
 - ii. The Director cum Mission Director, Integrated Child Development Services is permitted to authorize the Child Development Project Officers concerned to submit indent to the Managing Director, Tamil Nadu Civil Supplies Corporation Limited, Chennai for the supply of Double Fortified Salt (DFS).
 - iii. The Director cum Mission Director, Integrated Child Development Services is permitted to authorize the Child Development Project Officers of the concerned blocks of Salem, Vellore and Villupuram districts to draw and disburse the amount sanctioned in para-5(i) towards the procurement and supply of Double Fortified Salt (DFS) to the beneficiaries in the Anganwadi Centres in their respective blocks.

- iv. The Managing Director, Tamil Nadu Civil Supplies Corporation Limited, Chennai is directed to procure the required quantity of Double Fortified Salt from the Tamil Nadu Salt Corporation Limited, Chennai and supply the same to the Anganwadi Centres in Salem, Vellore and Villupuram Districts as per the indent placed by the Child Development Project Officers of the concerned Blocks.
- v. The Child Project Officers of the concerned block of Salem, Vellore and Villupuram district are directed to settle the bills to the Tamil Nadu Civil Supplies Corporation, Chennai towards supply of Double Fortified Salt (DFS).
- 6. The amount sanctioned in para 5(i) above shall be met from the State Innovation fund and debited to the following head of account:-

"2236. Nutrition – 02. Distribution of nutritious Food and beverages – 101. Special Nutrition Programmes – State's Expenditure JU. Provision of Double Fortified Salt to Ante Natal Mothers – Scheme under State Innovation Fund – 367. Feeding / Dietary Charges – 09. Others". (IFHRMS DP Code 2236-02-101-JU-36709). 7. The above expenditure shall be adjusted by deducting under the following head of account:-

"2236 - Nutrition - 02 Distribution of nutritious food and beverages - 902 Deduct - Amount met from State Innovation fund - State's Expenditure - JA Deduct - Amount met from State Innovation Fund - 330 Inter Account Transfers 01 - Inter Account Transfers".
