ORDER:-

The Hon'ble Minister, Social Welfare and Nutritious Noon Meal Programme has made the following announcement on the floor of Tamil Nadu Legislative Assembly while moving demand for grants of Social Welfare and Nutritious Programme for the year 2020-2021:-

2. In the letter second read above, the State Planning Commission has recommended for the provision of Supplementary Nutrition (Weaning Food containing amylase activity) (Sathu Mavu) to Old Age Pensioners in four districts viz., Ramanathapuram, Salem, Vellore and Villupuram at the cost of ₹ 209.12 lakh.

3. Based on the approval of the State Planning Commission and in order to reduce hunger among infirm old age pensioners, the Director cum Mission Director,

Integrated Child Development Services in her letter third read above has requested to sanction a sum of ₹2,09,12,000 (Rupees two crore nine lakh and twelve thousand only) towards procurement and supply of 100 gram Supplementary Nutrition (Complementary Weaning Food containing amylase activity) (Sathu Mavu) at the rate of ₹6.30 per day per beneficiary for 365 days to 9094 infirm/abandoned Old Age Pensioners in the four districts viz., Viilupuram, Vellore, Salem and Ramanathapuram from April 2020 to March 2021.

4. The Director cum Mission Director, Integrated Child Development Services has stated that the Sathu Mavu (Complementary Weaning Food) will be procured and supplied by the Weaning Food Manufacturing Women's Industrial Co-operative Societies functioning under the control of the Director cum Mission Director, ICDS in the concerned districts of the project implementation area. The Sathu Mavu (Complementary Weaning Food) will be given as Take Home Ration once in a month at their doorsteps by the Anganwadi Worker during the House visits. The weight and related health parameters will be measured in convergence with the health Department before and after the implementation of the project.

5. After careful examination of the proposal of the Director cum Mission Director, Integrated Child Development Services, the Government issue orders on the followings:-

- Sanction is accorded for a sum of ₹2,09,12,000 (Rupees two crore nine lakh and twelve thousand only) towards procurement and supply of 100 gram Supplementary Nutrition (Complementary Weaning Food containing amylase activity) (Sathu Mavu) at the rate of ₹6.3° per day per beneficiary *[]* for 365 days to 9,094 infirm/abandoned Old Age Pensioners in the four
 - districts viz., Ramanathapuram, Salem, Vellore and Villupuram from April 2020 to March 2021.
- ii. The Director cum Mission Director, Integrated Child Development Services is permitted to authorize the District Programme Officers of district concerned to submit indent for Supplementary Nutrition (Complementary Weaning Food containing amylase activity) (Sathu Mavu) with the Weaning Food Manufacturing Women's Industrial Co-operative Societies functioning under the control of Director cum Mission Director, Integrated Child Development Services in the concerned or nearby districts of the project implementation area.
- iii. The Director cum Mission Director, Integrated Child Development Services is permitted to authorize the District Programme Officers to draw and disburse the amount sanctioned towards the procurement and supply of Supplementary Nutrition (Complementary Weaning Food containing amylase activity) (Sathu Mavu).
- iv. The Director cum Mission Director is permitted to select the Weaning Food Manufacturing Women's Industrial Co-operative Societies from which the required quantity of Sathu Mavu (Complementary Weaning Food) is to be procured and supplied to infirm/abandoned Old Age Pensioners in Ramanathapuram, Salem, Vellore and Villupuram districts from April 2020 to March 2021.

v. The District Programme Officers of the concerned Districts viz., Ramanathapuram, Salem, Vellore and Viilupuram districts is authorized to settle the bills to the Weaning Food Manufacturing Women's Industrial Co-operative infirm/abandoned Old Age Pensioners in Viilupuram, Vellore, Salem and Ramanathapuram districts from April 2020 to March 2021.

vi. After completion of programme, the Director cum Mission Director, Integrated Child Development Services is directed to send a report thereon to Government.

6. The amount sanctioned in para 5(i) above shall be met from the State Innovation fund and debited to the following head of account:-

^{*}2236 Nutrition – 02 Distribution of nutritious Food and beverages – 101 Special Nutrition Programmes – JV Provision of Supplementary Nutrition as Sathu Mavu to Old Age pensioners - Scheme under State Innovation Fund – 367 Feeding / Dietary Charges -09 Others".
