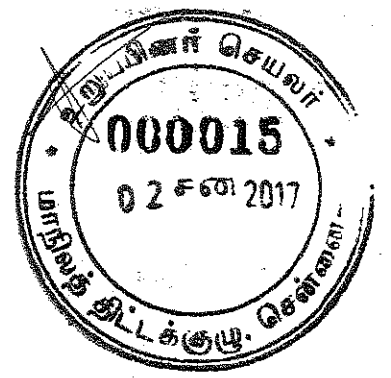

### ORDER :

In the letter read above, the Principal Chief Conservator of Forests has reported that the "Project of developing mobile application in Tamil and English for android phones and iOS phones and also to develop an online interface for Tree Plantation under various Government Schemes" is aimed to bridge the gap between the resources and the people and also to expose the opportunities and to explore the unpopular trees species, by using technological advancements. In order to implement the above said schemes the Principal Chief Conservator of Forests has requested the Government to sanction a sum of Rs.18.40 lakhs for developing mobile apps and an online interface for Tree Plantation under various Government Schemes, as indicated below:-

3. The Government after careful examination accept the proposal of the Principal Chief Conservator of Forests and accord sanction for a sum of Rs.18.40 lakhs (Rupees Eighteen lakhs and forty thousand only) for "Development of Mobile Applications (Tamil & English) and an online interface for Tree Plantation under various Government Schemes", under the Tamil Nadu Innovation Initiatives (TANII) for 2016 - 2017, for the works proposed at para 2 above.

4. (i). The expenditure sanctioned in para 3 above shall be debited to the following head of account :-

" 2406 FORESTRY AND WILD LIFE - 01. Forestry - 070 Communication and Buildings. SCHEMES IN THE TWELFTH FIVE YEAR PLAN - II. State Plan - JF. Development of mobile application (Tamil & English) and online interface for Tree plantation under various Government Schemes - Schemes under State Innovation Fund - 09 Grants - in-Aid- 03. Grants for Specific Schemes. (DPC - 2406 01 070 JF 0938)"

(ii). The expenditure shall be met from the State Innovation Fund by deducting under the following head of account :-

" 2406 FORESTRY AND WILD LIFE - 01. Forestry - 902 Deduct - Amount met from Reserve Fund - SCHEMES IN THE TWELFTH FIVE YEAR PLAN - II. State Plan - JA. Deduct - Amount met from State Innovation Fund - 30 Inter-Account Transfers. (DPC - 2406 01 902 JA 3001)"

And Contra - debiting the following fund account :-

"J- Reserve Fund - (b) Reserve Funds not bearing interest - 8229 - 00 - Development Welfare Funds - 200. Other Development and Welfare Funds - BE State Innovation Fund (DPC - 8229 00 200 BE 0006) (Outgo)"

5. Necessary funds are provided in the Revised Budget Estimates 2016-2017.

6. The Principal Chief Conservator of Forests is authorized to draw and disburse the amount sanctioned at para 3 above.
