ORDER:

In the letter first read above, the State Planning Commission has recommended proposal of Director of Handlooms and Textiles for installation of "Solar Power Panels for lighting load" to the Ramanathapuram Co-operative Spinning Mills for the year 2016-2017 (Round -II). The total project cost of the Scheme is Rs.115.63 lakh shared on 75:25 basis between Tamil Nadu Innovation Initiatives and Co-operative Spinning Mill respectively as indicated below:-

State Government Contribution (75%)	:	Rs.86.72 lakh
Co-operative Spinning Mill Contribution (25%)	:	Rs.28.91 lakh
<b>Total</b>	:	<b>Rs.115.63 lakh</b>

2. In the letter second read above, the Director of Handlooms and Textiles has stated that the Bharathi Cooperative Spinning Mill located at Ettayapuram in Thoothukudi District has the potential of more source for solar power. Hence, he has suggested that the Bharathi Cooperative Spinning Mills at Ettayapuram may be selected for installation of "Solar Power Panels for lighting load"

3. The Director of Handlooms and Textiles has requested the Government to sanction a sum of Rs.86,72,000/- as 75 % of the State Government share under "State Innovation Fund" for the year 2016-17 towards installation of "Solar Power Panels for lighting load" for Bharathi Co-operative Spinning Mills, instead of Ramanathapuram Co-operative Spinning Mill.

4. The Government after careful examination of the proposal of the Director of Handlooms and Textiles accord sanction for a sum of Rs.86,72,000/- (Rupees Eighty six lakh and seventy two thousand only) as 75% of State Government contribution towards installation of "Solar Power Panels for lighting load" for Bharathi Co-operative Spinning Mills under "State Innovation Fund" for the year 2016-2017.

5. The amount sanctioned in para 4 above shall be met from the State Innovation Fund and debited to the following head of account:-

"2851-00. Village and Small Industries - 103. Handloom Industries - Schemes in the Twelfth Five Year Plan-II. State Plan - LH Installation of Solar Power Panels in Co-operative Spinning Mills - Scheme under State Innovation Fund -09. Grants-in-Aid -03. Grants for Specific Schemes"

The above expenditure shall be adjusted by deducting under the following Head of Account.

2851-00. Village and Small Industries - 902. Deduct - Amount met from Reserve Fund / Deposit Account - Schemes in the Twelfth Five Year Plan-II. State Plan - JC. Deduct - Amount met from State Innovation Fund - 30. Inter- Account Transfers.

6. The Director of Handlooms and Textiles is authorised to draw and disburse the amount sanctioned in para 4 above. The Director of Handlooms and Textiles is also requested to ensure that after collecting the share of Co-operative Spinning Mill, the State share amount is released.

7. The Director of Handlooms and Textiles is requested to send the Utilisation Certificate to Government after completion of the project.
