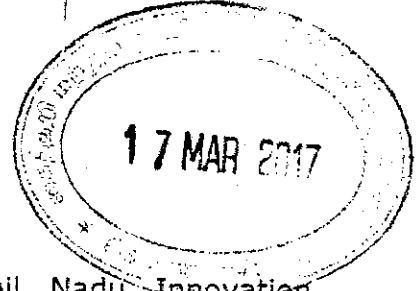

**ORDER:**

In the reference 1<sup>st</sup> read above, the state planning commission (SPC) has recommended installation of two "XRF Analyzers" at Kancheepuram and Kumbakonam for creating awareness among customers for the year 2016-2017. The total project cost of the scheme is Rs.50 lakh shared on 75:25 basis between TANII and Co-operative Society respectively as indicated below:-

State Government Contribution (75%)	:	Rs. 37.50 lakh
Co-operative Society (25%)	:	Rs.12.50 lakh

2. In the letter second read above the Director of Handlooms and Textiles has requested the Government to sanction a sum of Rs.37,50,000/- (Rupees Thirty Seven lakh and Fifty thousand only) as 75% State Government share under "State Innovation Fund" towards Installation of two "XRF Analyzers" at Kancheepuram and Kumbakonam to test quality of Zari in Silk Sarees for the benefits of customers.

3. The Government after careful consideration, accept the proposal of Director of Handlooms and Textiles and accord sanction a sum of Rs.37,50,000/- (Rupees Thirty Seven lakh and Fifty thousand only) as 75% State Government share towards Installation of two "XRF Analyzers" at Kancheepuram and Kumbakonam for creation of awareness among customers to test the quality of Zari under Tamil Nadu Innovation Initiatives for the year 2016-17.

4. The amount sanctioned in para-3 above shall be met from the state innovation fund and debited to the following head of account:-

"2851 - 00. Village and Small Industries - 103. Handloom Industries - Schemes in the Twelfth Five Year Plan - II State Plan - Creation of awareness in testing the quality of Zari - Scheme under State Innovation Fund - 09. Grants-in-Aid - 03 Grants for Specific Schemes"

The above expenditure shall be adjusted by deducting under the following head of account.

"2851-00.Village and Small Industries - 902. Deduct - Amount met from Reserve Funds/Deposit Account II. State Plan - JC. Deduct- Amount met from State Innovation Fund-30.Inter-Account Transfers"

5. The Director of Handlooms and Textiles is authorized to draw and disburse the amount sanctioned in Para-3 above. He is also requested to ensure that after collecting the beneficiaries societies share, the State share amount has to be released.

6. The Director of Handlooms and Textiles is requested to send an action taken report to the Government, periodically without fail.


