ORDER:

The District Collector, Thoothukudi in his letter first read above has stated that the State Nodal Officer, Mental Health Programme, Tamil Nadu has submitted a proposal to implement the Community Mental Health Project at Puliyampatti, Ottapidaram Taluk in Thoothukudi District at an estimated cost of Rs.116.94 lakh under the Innovation of Part-II Scheme with the following objective.

- i. To provide treatment to the persons living with Mental Illness in the Project area.
- ii. To cover the through treatment to the persons with Mental Illness who come to St. Antony's Church, Puliyampatti for faith healing prayers.
- iii. To prevent the negligence and exploitation of the Mentally ill persons.
- iv. To create awareness among the people on Mental Disability and eliminate the myths and misconception prevail among them.
- v. To provide skill training to the mentally ill person to bring them under mainstream to contribute the society through creating acceptance among the people.
- vi. To develop the sense of empowerment among the Caregivers to face the suffering and negligence in the society.
- 2. The District Collector, Thoothukudi has also stated that, the above project would benefit deserving population who are in the need of Mental Health Services. He has therefore recommended and forwarded the proposal for consideration and issue of necessary administrative and financial sanction for the effective implementation of the above project.
- 3. The proposal was examined by the State Planning Commission and the total Project cost is Rs. 105.81 lakh which includes Rs. 40.04 lakh towards staff cost and

Rs.14.21 lakh as organization consultancy charge to be paid to the RDTRPD trust The State Planning Commission has been appraised of the project in detail. Similar 2015-16 and it was considered that the proposed activities are to be taken inside the premises of the Shrine and therefore, suggested to implement the scheme on a camp based approach with a suitable evaluation component. As suggested earlier by the State Planning Commission now the proposal is resubmitted. In the revised project, the treatment clinic for mentaly ill is to be started in the nearby area of the St. Antony's Church, Pullyampatti where faith healing is combined with Medical treatment. The State Planning Commission after detailed deliberation has decided to recommend the proposal by excluding the staff cost. Further, the payment of Rs. 14.21 lakh to be paid to the RDTRPD Trust as organization consultancy charge may be decided by the Government.

4. The Government after careful examination, accord sanction for a sum of Rs.51,56,000/- lakh. (Rupees Fifty one lakh and fifty six thousand only) for implementation of community Mental Health Project at Pullyampatti, Ottapidaram Taluk in Thoothukudi District under Tamii Nadu Innovation Initiatives (TANII) schemes 2016-17 as detailed in the Annexure of this order without any consultancy charges.

5. The amount sanctioned in para 4 above shall be met from the State innovation fund and debited to the following head of account:
