ORDER

The Standing Finance Committee has approved the proposal of the Director (i/c), Forensic Sciences Department, Chennai, for creation of a "Mobile Device Forensic Division" in the Forensic Sciences Department, Chennai, at a total outlay of Rs.25.50 lakh for a period of three years under the Tamil Nadu Innovation Initiatives Schemes, as detailed below:-

In the Government order eighth read above, necessary funds have been provided in the First Supplementary Estimates for the year 2016-2017.

2. Accordingly, the Government accord administrative sanction for a sum of Rs.25.50 lakh (Rupees twenty five lakh and fifty thousand only) for the three years from 2016-2017 to 2018-2019 and also accord financial sanction for a sum of Rs.21.50 lakh (Rupees twenty one lakh and fifty thousand only) for the year 2016-2017 for procurement of the following softwares and hardwares along with accessories towards creation of a "Mobile Device Forensics Division" in the Forensic Sciences Department, Chennai:-
