The following Project of Tamil Nadu Agricultural University has been approved by the State Planning Commission under Tamil Nadu Innovation Initiatives (TANII) Projects for the year 2016-2017.

- i. Mitigating occupational drudgery of farm women through ergonomic interventions $-(Rs.177.00 \text{ lakh}; 1^{\text{st}} \text{ year budget } Rs.83.00 \text{ lakh})$
