## Orders:-

In the reference cited, the Director of Elementary Education has recommended the proposal of the Transformation of Toilets into Child friendly has follows:

"the Honorable Chief Minister has laid greater emphasis in providing Toilets for boys and girls in all the Government Schools. Under her able guidance, a complete survey was taken by the School Education Department in co-ordination with Rural Development and Panchayat Raj Department in 2011-2012 for arriving at the gap. Priority has been given to fill up the gaps and special emphasis given for construction of separate toilets for girls common toilets and toilets for children with special needs. This has resulted in 100% coverage of toilets and drinking water facilities in all the Government Schools. In fact Tamil Nadu is the fore-runner in completing 100% coverage of toilets facilities in all Government Schools.

- 2. The Director of Elementary Education has stated that, the toilets can be made interesting with beautiful caricatures of petsanimals and cartoon pictures of Tom and Jerry Mickey Mouse, Dora Bujji on the Wall. These toilets would also promote proper hygiene habits like hand wash after toilets. The components of child friendly toilets are
  - ✓ Provisions of hand bars/door latches at the height of the child level
  - ✓ Attractive pictures to be painted on the walls of toilets.
  - ✓ Planting and maintaining a garden surrounding the toilets (Even in access path)
  - ✓ Hand washing facilities; a mirror, small towel, soap and dipping cup
    along with the wash basin at the Child level.

These child friendly toilets may be implemented in Six Schools per district on a pilot

basis in the following phased manner.

- In Phase-I, Six Schools in each District
- In Phase-II, Another Six Schools in each District
- In Phase-III, Six more schools in each district

- 5, The expenditure sanctioned in para 4, above shall be debited to the following Head of Account:
  - "4202- Capital outlay on Education, Sports Art and Culture 01 General Education —201 Elementary Education Schemes in the twelfth five year plan Il State Plan —JG Transformation of Toilet into Child friendly schemes under State Innovation Fund 16 Major Works".
