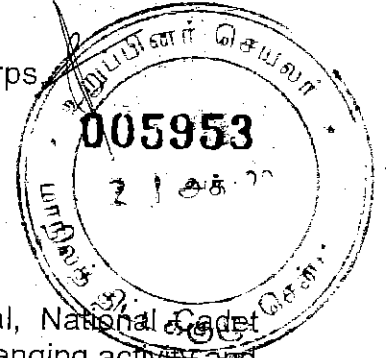

**ORDER:**

In the letter read above, the Deputy Director General, National Cadet Corps has stated that the rock climbing is an exciting and challenging activity and provides an excellent environment for building leadership, self-confidence and teamwork skills. The National Cadet Corps cadets are undergoing various mountaineering and rock climbing camps. Provision of Artificial Rock Climbing set up at National Cadet Corps Training Academy at Idayapatti Village will give a handful of experience to cadets for climbing rock and can facilitate training to 700 cadets at the camp period. It also motivates the cadets to join National Cadet Corps for the various adventure activities involved in the National Cadet Corps alongwith training. He has therefore requested for installing the above said facility at a total outlay of Rs.30.00 lakhs under Tamil Nadu Innovation Initiatives (TANII).

2. The Deputy Director General, National Cadet Corps has therefore requested the Government to issue necessary administrative and financial sanction under Tamil Nadu Innovation Initiatives for establishment of Artificial Rock Climbing setup at National Cadet Corps Training Academy, Idayapatti Village, Madurai District for a sum of Rs.30.00 lakhs (Rupees thirty lakhs only) at the earliest.

3. Subsequently, the Hon'ble Chief Minister has made an announcement on 24.08.2016 on the floor of the Assembly under Rule 110 during the Budget Session 2016-17 that an Artificial Rock Climbing setup will be established at National Cadet Corps Training Academy, Idayapatti Village, Madurai District at a cost of Rs.30.00 lakhs.

4. The Government after careful examination, sanction a sum of Rs.30.00 lakhs (Rupees thirty lakhs only) as non-recurring expenditure to the National Cadet Corps Directorate towards the establishment of Artificial Rock Climbing setup at National Cadet Corps Training Academy, Idayapatti Village, Madurai District, under Tamil Nadu Innovative Initiatives for the year 2016-17.

5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:

"4202 Capital Outlay on Education, Sports, Art and Culture- 03 Sports and Youth Services - 800 Other Expenditure – Schemes in the Twelfth Five Year Plan– II. State Plan - JD Artificial Rock Climbing set up at National Cadet Corps Training Academy at Idayapatti – Schemes under State Innovation Fund – 16 Major Works." (DPC 4202 03 800 JD 1601)

6. The above expenditure shall be met from State Innovation Fund by deduction under the following head of account:-

"4202 Capital Outlay on Education, Sports, Art and Culture- 03 Sports and Youth Services – 902 Deduct – Amount met from State Innovation Fund – Schemes in the Twelfth Five Year Plan – II. State Plan - JA Deduct – Amount met from State Innovation Fund – 30 Inter-Accounts Transfers." (DPC 4202 03 902 JA 3001)

"And contra debiting J Reserve Fund (b) Reserve Funds not bearing interest -8229 00 Development and Welfare Funds – 200 Other Development and Welfare Funds – BE State Innovation Fund." (DPC 8229 00 200 BE 0006) (outgo)

7. The Deputy Director General, National Cadet Corps is the estimating reconciling and controlling authority for the above new head of account.

8. The Deputy Director General, National Cadet Corps is authorized to draw and disburse the amount sanctioned in para 4 above. The Deputy Director General, National Cadet Corps shall send the detailed expenditure report, utilization certificate etc. to Government at the appropriate time.
