ORDER:

The Hon'ble Minister for Social Welfare and Nutritious Noon Meal Programme made on announcement on the floor of Tamil Nadu Assembly on 24.06.2017 is "Early Intervention Services to Children with Disabilities (0-6 years) through Community Based Approach and Home Based Approach with use of TABLET at a cost of Rs.12,48,000/-. The above project was also approved by TANII-2017-2018 (First Round) by the State Planning commission.

2. The State Commissioner for the Differently Abled in his letter read above has stated that, based on the announcement made by the Hon'ble Minister Social Welfare and Nutritious Noon Meal Programme, on the floor of the Tamil Nadu Legislative assembly to carry out a pilot study in Tirumangalam block in Madurai District and Kabilarmalai block in Namakkal district during the year 2017-18 and also requested the Government to accord sanction of Rs.12.48 lakhs for "Early Intervention Services to children with Disabilities (0-6) through Community Based Approach and Home Based Approach with use of TABLET Further he has also requested to permit the State Commissioner for the Differently Abled to implement this project through an implementing agency/ Non Governmental Organisation working in this field in coordination with the staff/office of District Differently Abled Welfare Officers of Madurai and Namakkal districts and other Non Governmental Organisations implementing Early Intervention Centres in these districts.

3. The Government after careful examination, of the proposal of the State Commissioner for the Differently Abled and accord sanction for a sum of Rs.5.10.000/-(Rupees five lakhs and ten thousand only) towards the Early Intervention Services to Children with Disabilities (0-6 years) through Community Based Approach and Home Based Approach with use of TABLET* Pilot study in one block at Madural and another block at Namakkal districts under TANII (2017-2018) as detailed below:-
