

ABSTRACT

ORDER:

In Government Order first read above, orders were issued to implement a pilot project to access the feasibility of developing a local ST Elevation Myocardial Infarction (STEMI) system of care and to test the feasibility and effectiveness of the two strategies in ST Elevation Myocardial Infarction (STEMI) management i.e. Primary Percutaneous Coronary Intervention (PCI) in those patients with short transportation times and Pharmaco-invasive strategy in those with long transportation times. It was also permitted for pilot testing with Hub and Spoke model with three Private Medical institutions empanelled under Chief Minister Comprehensive Health Insurance Scheme and two Government Medical institutions. Permission was also granted to utilize the '108' ambulances for transportation.

2. In continuation of the successful implementation of the Project, in Government Order 2nd read above, orders were issued for the extension of the project for the observational study of Pharmaco-invasive strategy with Reteplace in patients with ST Elevation Myocardial Infarction-RePAMI with Hub and Spoke model

3. The Mission Director, State Health Society has stated that the aim of project for strengthening the Cardiac Care Network in Tamil Nadu are as follows:-

- i. to establish HUB and Spoke model to strengthen the cardiac care network in Tamil Nadu, in particular ST Elevation care.
- ii. to reduce the morbidity and mortality related to MI in particular ST Elevation.
- iii. to improve critical cardiac care transportation through 108 Ambulance Services.

- IV. to generate systems to increase the public awareness of the importance of early treatment in ST Elevation Myocardial Infarction (STEMI) cases.
- V. to generate systems to increase the public awareness for the need of below poverty level patients to have Chief Minister's Comprehensive Health Insurance Scheme card available to them
- VI. to improve the networking of the Chief Minister's Comprehensive Health Insurance Scheme linking it to ration card and ability to provide the necessary clearance for the procedure without delay to the patients

4. The Mission Director, State Health Society has also stated the roles and responsibilities of the parties involved in this project are as follows:-

- National Health Mission will act as the Nodal Agency for this Project.
- Emergency Management Research Institution (EMRI) will be involved for 108 Ambulance.
- The Director of Medical Education / Director of Medical and Rural Health Services institutions are the part of HUB & Spoke model.
- Chief Minister's Comprehensive Health Insurance Scheme (CMCHIS) for risk pooling.
- ST Elevation Myocardial Infarction (STEMI) India for protocols & Training.

5. The Mission Director, National Health Mission has therefore requested Government order to strengthen the Cardiac Care network in Tamil Nadu.

7. The above proposal was examined by the State Planning Commission and appraised as a proposal under Tamil Nadu Innovation Initiatives 2017-2018, and recommended to implement the project with the outlay of Rs. 925.2 lakh for a period of three years i.e. 584.40 lakh for first year, 195.40 lakh for second year and 145.40 lakh for third year. The proposal has been approved by the standing Finance Committee to be funded under State Innovation fund.

8. After careful examination the Government have decided to accept the proposal of Mission Director, National Health Mission and accordingly issue the following orders:-

- i. Administrative sanction is accorded for strengthening the cardiac care network in Tamil Nadu under Tamil Nadu Innovation Initiatives with (TANII) an amount of Rs. 925.2 lakh for a period of three years. The break-up details of the cost of the project is annexed with this order.
- ii. The cost of the project is approved to be funded under State Innovation Fund over a period of three years as detailed below:-

- iii. A sum of Rs.584.40 lakh (Rupees five crore eighty four lakh and forty thousand only) is sanctioned for the financial year 2017-18 to establish HUB and Spoke model in Tamil Nadu for strengthening the cardiac care network under Tamil Nadu Innovation Initiatives(TANII).

- iv. The Mission Director, State Health Society is permitted to improve critical cardiac care transportation through 108 Ambulance Service.
- v. The Mission Director, State Health Society is also permitted to generate a system regarding to increase the public awareness on the importance of early treatment in ST Elevation Myocardial Infarction (STEMI) cases and to increase the public awareness on the need of Below Poverty Level patients to have Chief Minister's Comprehensive Health Insurance Scheme (CMCHIS) card available with them.
- vi. The Mission Director, State Health Society is also permitted to improve the network for linking ration card with Chief Minister's Comprehensive Health Insurance Scheme (CMCHIS) to provide necessary clearance without delay to the patients.
- vii. The role and responsibilities of the parties is fixed as follows:-
 - National Health Mission shall be act as the Nodal Agency for this Project.
 - Emergency Management Research Institution shall be involved for 108 Ambulance.
 - The Director of Medical Education / Director of Medical and Rural Health Services institutions shall be the part of HUB & Spoke model.
 - Chief Minister's Comprehensive Health Insurance Scheme (CMCHIS) for risk pooling.
 - ST Elevation Myocardial Infarction (STEMI) India for protocols & Training.

9. The expenditure sanctioned in para 8(iii) above shall be debited under the following head of account:-

"2210 - Medical and Public Health – 80 General – 800 Other Expenditure – State's Expenditure – JP Cardiac Care Network – Scheme under State Innovation Fund – 09 Grants-in-Aid - 03 Grants for Specific Schemes"

The amount shall be met from the State Innovation fund by deducting the following head of account:

2210 – Medical and Public Health – 80 – General – 902 – Deduct – Amount met from State Innovation Fund – JB – Deduct Amount met from State Innovation Fund – 30 – Inter – Account Transfers

(DPC -2210 80 – 902 – JB – 3000)

And Contra debiting the following head of account:

J – Reserve Fund (b) Reserve Funds not bearing interest

10. The Mission Director, National Health Mission / Project Director, Reproductive Child Health Project is authorized to draw and disburse the fund sanctioned in para 7(iii) above. The Accountant General of Tamil Nadu is requested to make necessary book adjustment regarding the drawal of fund from the State Innovation Fund account.
