### Order:

In the Government order first read above, sanction was accorded for a sum of Rs.99,25,000/- towards creation of a Community Help Desk with Skype facility and Development of Multi Dimensional Communication Tools using technological solutions in 16 districts under Tamil Nadu Innovation Initiatives (TANII) for the year 2017-18 for carrying out the activities such as Monitoring and Evaluation Base Line Study, Creation of Community Help Desk with Skype facilities for 16 districts @ Rs.1,00,000 per District, Friends in Need Program, Radio Campaign for all Districts and LED Di Gi Scroll boards for 16 Districts @ Rs.75,000/- per District.

- 2. In the letter second read above, the Commissioner of Social Welfare has requested the Government to sanction a sum of Rs.94,75,000 for Creation of Community Help Desk and Development of Multi Dimensional Communication tools for the year 2017-2018 in second phase for the balance 16 districts under the second round of TANII and also to permit her to draw the same under Article 99 of Tamil Nadu Financial Code Volume I.
- 3. After careful examination of the proposal of Commissioner of Social Welfare, the Government hereby accord sanction for a sum of Rs.94,75,000/- (Rupees Ninety four lakh and seventy five thousand) for Creation of Community Help Desk and Development of Multi Dimensional Communication tools for the year 2017-2018 in second phase for the balance 16 districts under the second round of Tamil Nadu Innovation Initiatives and also to permit her to draw the same under

Article 99 of Tamil Nadu Financial Code Volume – I for carrying out the activities under TANII, as detailed below:-
