#### ORDER:-

In the reference first read above, the State Planning Commission has, among others, recommended for provision of equipment for Cochlear Implantation Centre in five Government Medical College Hospitals at Salem, Thoothukudi, Tirunelveli, Dharmapuri and Chengalpattu at a cost of Rs.3.75 crore under Tamil Nadu Innovation Initiatives (TANII) (Round – II) for the year 2017-2018.

2. Based on the above recommendation, in the reference second read above, the Mission Director, State Health Society has forwarded a proposal and requested the Government to accord administrative and financial sanction for providing of equipment to Cochlear Implantation Centre in five Government Medical College Hospitals at Salem, Thoothukudi, Tirunelveli, Dharmapuri and Chengalpattu at a cost of Rs.3.75 crore under Tamil Nadu Innovation Initiatives (TANII) (Round – II) for the year 2017-2018.

3. The Government, after careful examination of the proposal of the Mission Director, State Health Society hereby accord administrative and financial Sanction

- (i) for Provision of equipment for Cochlear Implantation Centre at the five Government Medical College Hospitals at Salem, Thoothukudi, Tirunelveli, Dharmapuri and Chengalpattu through TANII Scheme under State Innovation Fund at a cost of Rs.3.75 crore (Rupees Three core and seventy five lakh only) at Rs.75.00 lakh per centre; and

(ii) The Mission Director, National Health Mission, State Health Society, Tamil Nadu is permitted to procure the following Audiological Equipment and Surgical Equipment for the Cochlear Implantation Centre at the five Government Medical College Hospitals as detailed below:-

4. The amount sanctioned in para 3 above shall be debited to the following head of account :-

"2210. Medical and Public Health – 01. Urban Health Services – Allopathy – 110. Hospitals and Dispensaries – State's Expenditure – LR. Equipments for Cochlear Implantation in 5 Medical College Hospitals under State Innovation Fund – 19. Machinery and Equipments – 01 – Purchase" (DPC - 2210 - 01 - 110 – LR - 1913)

The amount shall be met from the State Innovation Fund by deducting the following head of account:-

"2210. Medical and Public Health – 01. Urban Health Services – Allopathy – 902. Deduct amount met from State Innovation Fund – JB. Amount met from State Innovation Fund – 30. Inter account Transfers."

And contra debiting the following head of account:-

"J. Reserve Fund (b) Reserve Funds not bearing interest – 8229.00 – Development and Welfare Funds – 200. Other Development and Welfare Funds - BE. State Innovation Fund."  
(DPC – 8229.00 – 200 – BE - 0006 outgo)

5. Necessary funds have been provided in Supplementary Estimates 2017-2018. The Mission Director, State Health Society is authorized to draw and disburse the amount sanctioned in para 3 above to the Personal Deposit Account of the Managing Director, Tamil Nadu Medical Services Corporation Limited, Chennai.

6. The Mission Director, State Health Society is also directed to procure and install the equipment through Tamil Nadu Medical Services Corporation Limited, Chennai. Further, the amount sanctioned towards purchase of equipment shall not be paid in cash, but shall be credited to the following Personal Deposit Account of the Managing Director, Tamil Nadu Medical Services Corporation Limited, Chennai :-

"K. Deposits and Advances (b) Deposits not bearing Interest - 8443.00. Civil Deposits – 800. Other Deposits – CE. Deposits of Tamil Nadu Medical Services Corporation Limited, Chennai"
